OFFICIAL RULES

Description of Contest: This is a dart league player participation contest that awards prizes to winning J&J Amusements league players for participating in J&J Amusements Player Reward Program Dart Leagues. Player/Contestants can increase their likelihood of winning a prize by participating in multiple eligible leagues and league nights.

Contest Period: Contest runs from February 1, 2021 through 11:59 p.m. CDT July 31, 2021.

Winner determined by random draw of eligible entries to be held at the J&J Amusements 2020-21 PRP Finale in August 2021*. YOU DO NOT NEED TO BE PRESENT TO WIN ANY PRIZE. (* Drawing date subject to possible change.)

How to enter: Every time you play <u>5 matches</u> in a J&J Amusements Player Reward Program Dart League or NADO remote league on a J&J Amusements dart board during the contest period your name will be entered into the League Participation Contest drawing.

How to win: At the end of the contest period a drawing will be conducted at the J&J Amusements 2020-21 PRP Finale in August 2021* to determine the prize winners. If selected the name on the entry will be awarded the respective prizes listed.

Contestant Eligibility: A player 18 years of age that completes at least 5 nights of eligible league play during the contest period. Contestant must be 18 at time of play.

Ineligible: J&J Amusements employees, immediate family members (spouses, parents, siblings, and children) or household members of employees are ineligible. Employees, outside contractors, agents, and representatives (whether paid or unpaid) of a dart game manufacturer, distributor or operator or a

competing dart league operator are ineligible. A contestant may not be a location owner or if in Illinois; an owner or Person with Significant Influence or Control (as defined in the Illinois Gaming Board's Rules promulgated pursuant to the Illinois Video Gaming Act).

Agreement to Official Rules: Participation in the contest constitutes full and unconditional agreement to and acceptance of the Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

Winner Notification: Winners will be announced and posted on the Sponsor's website and Facebook page (http://Leagues.JJVentures.com & http://facebook.com/JJVentures).

Prizes: Prizes are not transferrable or exchangeable and cannot be redeemed for cash. Winning contestants are responsible for any applicable state and federal taxes associated with winning a prize.

GRAND PRIZE: SPIDER 360 2000 SERIES DARTBOARD (Approx. value \$3,500.00)

(Awarded to player on the selected entry.) Includes delivery to the winner's local J&J Amusements market office. Prize winner is responsible for picking up or scheduling delivery from the local office. Prize winner is responsible for any associated delivery costs from their local office to final point of delivery. Delivery by the local office is not guaranteed and the prize may need to be picked up by the winning contestant.

2nd PLACE PRIZE: **1 YEAR'S J&J AMUSEMENTS LEAGUE FEES** (Approx. value \$0.00 to \$1,000.00 each depending on number of league matches played.)

(Awarded to the player on the selected entry) All J&J Amusements League and NADO League Fees from NADO Player Rewards Program Leagues paid excluding cost of games for the 2021-22 J&J/NADO Player Rewards Program season (July 1, 2021 - June 30, 2022 in form of rebate at end of season). Amount of rebate may not exceed \$1,000 per prize winning player. Only for matches scheduled in the listed time frame. Does not include make-up matches or matches played ahead. Does not include leagues that do not participate in the J&J/NADO Player Rewards Program.

3rd PLACE PRIZE: **HOTEL & ENTRY FEES TO NADO 2020-21 SEASON CONTINENTAL FINALE** (Approx. value = Up to \$350.00 each)

(Awarded to the player on the selected entry) 2 Nights Hotel at the tournament venue and all entry fees paid for the NADO 2020-21 Season Continental Finale on October 1-3, 2021 for the winner.

Restrictions: Sponsor reserves the right to substitute any prize for a comparable prize of equal or greater value should the prize become unavailable by the end of the contest. Prize winners are responsible for any taxes associated with winning the prize. In the event a player is drawn for more than one prize they will only be awarded the higher valued prize and a redraw will take place for that prize spot only.

Disqualification:

- Players that are disqualified from league participation under normal league rules during the contest period will be disqualified from this event.
- Contestants or players may be disqualified for reasons that would damage the integrity of the contest and the J&J Amusements Player Reward Program or a NADO Player Rewards Program including but not limited to any of the following: Cheating, unsportsmanlike conduct or any

other infraction that damages the integrity of the program whether the infraction takes place during this contest or during any J&J Amusements or NADO Player Reward Program or tournament event. Sponsor shall have sole and final discretion in application of this rule. Any disqualification may result in prize(s) being revoked or redrawn for that prize spot only.

 does not control the actions of the franchisees and as such cannot be held responsible should a
 franchisee's event be cancelled, postponed, rescheduled or have rule changes that would make
 contest participants ineligible to compete. Should some unforeseen issue occur that would
 drastically affect the sponsor's ability to award the prize or the prize winner's ability to
 participate, the sponsor reserves the right to provide a substitute prize at its discretion.
- Alternate Method of Entry: You may enter the contest without having to play in a J&J Amusements league. This can be accomplished by completing these steps:

 - 2. Every time you visit <u>5 matches</u> in a J&J Amusements Player Reward Program Dart League during the contest period your name will be entered into the League Participation Contest drawing. Limit of one eligible visit per day towards entry count.
