## DART LEAGUE RECRUITING CONTEST

- **GRAND PRIZE: Your Choice of 1 of 3 Amazing and Fun Filled Dart Tournament Trips**

### OFFICIAL RULES

**Description of Contest:** This is a dart league player recruiting contest that awards prizes to winning JJVA league players that recruit qualified 'NEW' players into a J&J Ventures Amusements Player Reward Program Dart League. Player/Contestants must meet certain league play requirements to be able to relate their league experience to potential recruits and to utilize tournament and league entry prizes. Player/Contestants can increase their likelihood of winning a prize by recruiting additional 'NEW' players. Knowledge and experience of JJVA programs will greatly enhance recruiting abilities.

**Contest Period:** Contest runs from January 1, 2018 through 11:59 p.m. June 30, 2018

**How to enter:** Every time you recruit a qualified 'New' player in the JJVA North Dart League program during the contest period your name along with the name of your recruit will be held for possible entry into the Recruiting Contest drawing.

**How to win:** At the end of the contest period, for each qualified 'New' player that meets the eligibility and minimum play requirements in the JJVA Dart League program during the contest period, the recruiter's name along with the name of the recruited player will be entered as a single entry into the pool of entries.

A drawing will be conducted at the JJVA North Market Dart Player Rewards Finale held in the Summer of 2018 (exact date TBD) to determine the prize winners. If selected, each name on the entry (recruiter and recruit) will be awarded the Grand Prize per prize rules. **YOU DO NOT NEED TO BE PRESENT TO WIN any prize**

**New Player:** Any player at least 21 years of age that has played less than 4 J&J Ventures Amusements or Allied Games Rockford league matches of any type (pool or dart leagues including junior & remote) during the period from January 1, 2017 and the recruiting date. To be counted as a **New Player** the **New Player** must complete at least 8 nights of J&J Ventures Amusements North Player Reward Program League play in the JJVA North dart league program during the contest period. A **New Player** may only be counted as a **New Player** one time and by only one contestant regardless of whether the **New Player** competes in more than one league or not. A **New Player** that has already deemed to have been recruited by one player based upon the first or earliest verification form is ineligible to be recruited by another contestant regardless of that contestant's eligibility status or whether that contestant remains eligible by virtue of game play requirements, disqualification or any other reason. A contestant may not transfer credit for a **New Player** recruited by him or her to any other contestant for any reason.

**Contestant Eligibility:** Open to any J&J Ventures Amusements North league player 21 years of age that completes at least 8 nights of league play during the contest period. A **New Player** can also be a 2018 North Dart League Recruiting Contest recruiter contestant.

**Ineligible:** J&J Venture's employees, immediate family members (spouse, parents, siblings and children) or household members of employees are ineligible. Employees, agents and representatives (whether paid or unpaid) of a dart game manufacturer, distributor or operator or a competing dart league operator are ineligible. A contestant may not be an owner, manager, employee or representative of any JJVA dart league location. Additionally, a contestant may not hold or be an applicant for an Illinois Video Gaming Location License or be an agent, manager, employee or representative for any person or entity that holds or has applied for an Illinois Video Gaming Location License.

**Agreement to Official Rules:** Participation in the contest constitutes full and unconditional agreement to and acceptance of the Official Rules and the decisions of the Sponsor, which are final and binding. Winning a prize is contingent upon being compliant with these Official Rules and fulfilling all other requirements set forth herein.

**Verification: New players** must indicate on the Verification Form the name of their recruiter and verify with their (the new player's) signature. Since **New Players** are required to play a minimum of 8 nights of league play, signed Verification Forms must be submitted by the recruiting contestant to the Sponsor as indicated on the form or photos/scanned images of the forms emailed. **Forms must be postmarked or emailed no later than 14 days after the first night of league play of the New Player.** **New Players** may not be registered after May 30, 2018. Sponsor shall not be liable or responsible for any verification forms lost or delayed by the U.S Postal service or any other means of delivery. Forms may also be submitted by email to [leagues@JJVentures.com](mailto:leagues@JJVentures.com). Forms submitted by email should also use the 'read receipt' option. (For extenuating circumstances, the sponsor reserves the right to extend the verification deadline.)

**No Purchase Necessary:** You can be a recruiter or recruited player without having to play in a JJVA league. This can be accomplished by fulfilling the time obligations that are the same as a regular league player recruiter or new player recruit. Complete the League Builder Recruiting Contest sign-up form. In the section "Team Playing On" enter "Non-Player". Indicate the "League Name and night" that you wish to participate in as a non-player. Mail that form to us prior to the start of league scheduling as indicated on our website or Facebook page. You will be assigned to a team as a non-player. Follow that team's league schedule on-line and show up at the required number of league matches the same as a regular league player. For verification purposes, for each night of league attendance take a picture of yourself with both competing teams prior to the start of scheduled matches and again at the end of the last scheduled match. Print and send a copy of the photos within 5 business days of the league match play date by US Postal Service to J&J Ventures Amusements, Attn: JJVA North Market Dart League Recruiting Contest, P.O. Box 1709, Effingham, IL 62401.

**Winner Notification:** Winners will be announced and posted on the Sponsor's website (<http://Leagues.JJVentures.com>) and Facebook page ([www.facebook.com/jjventures](http://www.facebook.com/jjventures)).

**Prizes:** Prizes are not transferrable or exchangeable and cannot be redeemed for cash. If any of the Grand Prize-winning contestant(s) is unable to commit to take the travel prize by August 31, 2018 then the prize will be rescinded and may or may not be re-awarded at the sponsor's discretion. Winning contestants are responsible for any applicable state and federal taxes associated with winning a prize.

**Grand Prize: Choice of one of the Dart Tournament Travel Prizes as described below:** (Approximate value between \$600.00 and \$900 for each winner depending on prize selected)

- Round trip airfare and double occupancy accommodations for the recruited player and their recruiter to one of the following:
  - **2018 Bullshooter South Carolina Dart Tournament expected to be in Myrtle Beach, SC;** Round trip airfare from Chicago, IL, 5 nights double occupancy accommodations at the event hotel for the recruit and the associated recruiter.
  - **2018 Bullshooter Florida Dart Tournament expected to be in Kissimmee, FL;** Round trip airfare from Chicago, IL, 5 nights double occupancy accommodations at the event hotel for the recruit and the associated recruiter.
  - **2019 National Dart Association Team Dart expected to be in Las Vegas;** Round trip airfare from Rockford, IL, 7 nights double occupancy accommodations at the event hotel for the recruit and the associated recruiter.
- Event Entry Fees into dart tournament events are the responsibility of the contestant(s). The contestant(s) is responsible for meeting any eligibility requirements of the event selected. The sponsor will not be held responsible for any rules of the event that may disqualify a player from participation.

- Restrictions:
  - Tournament dates, locations, venues, eligibility requirements and rules are controlled by the various event sponsors and are outside the control of this contest sponsor. This contest sponsor may not be held liable for any changes in itinerary, travel dates, etc. that may be required due to any changes the event sponsors may institute.
  - Air travel departure and return dates will be determined by the sponsor.
  - Sponsor reserves the right to select airline, airline seating selection, hotel, room type and travel schedule based upon best available rates.
  - Air travel and/or lodging changes and other expense items outside the scope of the original Grand Prize parameters requested by the winner(s) shall be at the winner's expense. Example: This prize is double occupancy and should the winning recruit and their recruiter desire separate or additional rooms then the additional room charge will be at their expense.
  - Both the recruit and recruiter are expected to be able to agree on the choice of their double occupancy trip prize option. In the event they are unable to agree then the choice of the full trip option (airfare & hotel) will be awarded to the recruited player and airfare only will be awarded to the recruiting player for the trip option of their choice.

**Restrictions to receive prizes:** Proof of ability to accept prizes is required by all winning contestants. This includes but is not limited to; availability to travel on posted travel dates, required transportation documents and any other items or costs necessary to complete the trip.

**Disqualification:**

- New players that are disqualified from league participation under normal league rules during the contest period will not be counted toward their recruiter's player count.
- Contestants that are disqualified from league participation under normal league rules during the contest period will be disqualified from the contest.
- Contestants or players may be disqualified for reasons that would damage the integrity of the contest and the J&J Ventures Amusements league program including but not limited to any of the following: Cheating, misrepresentation of the J&J Ventures Amusement league program or associated prizes, unsportsmanlike conduct or any other infraction that damages the integrity of the program whether the infraction takes place during this contest, on social media, during any JJVA league or tournament event or at any other venue. J&J Ventures Amusements' league management shall have sole and final discretion in application of this rule. Any disqualification may result in prize(s) being revoked.

**Additional Legalese:**
